

**FHF Mexico, Inc.'s Rocky Point, Mexico Service Trip
Consent and Release of Liability
(December 2015 & January 2016)**

I certify that I am voluntarily participating in FHF Mexico, Inc.'s ("FHF") and Casas Perpetuales Parker, A.C. ("CPP") Rocky Point, Mexico Service Trip (the "Event"). I understand and acknowledge that, although the Event has been organized by FHF and CPP, I am responsible for all of my travel costs and expenses, including but not limited to airfare, car rental fees, fuel, food and lodging.

I specifically recognize that FHF is a non-profit corporation and that the only funds held by FHF are donations made by individuals and some businesses and that these funds are used to acquire land and build homes for needy families in Mexico. I do not expect nor will I pursue any legal efforts to obtain money from FHF or CPP or personally from its officers, directors, representatives, employees and agents or from CPP for any personal or property damage that I or my minor children may suffer as a result of participating in the Event.

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ALL ACTIVITIES ASSOCIATED WITH THE EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the Released Parties (defined below), from dangerous or defective vehicles or equipment, or the condition of property owned, leased, or controlled by them. Organized Event activities may include but are not limited to driving a vehicle or riding as a passenger in a vehicle to/from various Event activities, attending and participating in Event activities, to include home construction, organized meals and any other activities in which I choose to participate. I certify that I have been advised by the "Released Parties" to not engage in any physical work on the project at the Event that I am not comfortable and confident in my ability to perform.

I certify that I am physically fit and am sufficiently prepared for participation in the Event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in the Event.

I acknowledge that this Consent and Release of Liability Form will be used by FHF and that it will govern my actions and responsibilities during the Event.

In consideration of my participating in the Event, I hereby take action for myself, my minor children, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

- (A) *I UNCONDITIONALLY WAIVE, RELEASE, AND DISCHARGE* from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me or my minor children, including my traveling to and from this Event, *THE FOLLOWING ENTITIES OR PERSONS*: FHF and CPP and/or their respective directors, officers, employees, representatives and agents (the "Released Parties");
- (B) *I PROMISE NOT TO SUE, TO INDEMNIFY AND TO HOLD HARMLESS* the Released Parties from any and all liabilities or claims made as a result of my, or my minor children's participation, in the Event, whether caused by negligence or otherwise, including but not limited to Released Parties alleged failure to adequately train, instruct, warn and prepare me or my minor children to properly engage in the construction of houses and other buildings and other activities during the Event.

I acknowledge that the Event, like any experience, may involve strenuous physical and mental work, and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by temperature and weather, the condition of participants, vehicles, roadways and equipment, and actions of other people.

I understand that the Mexican government is engaged in an extensive effort to counter organized criminal activity throughout Mexico. I also understand that crime and violence are serious problems that can occur anywhere in Mexico, including resort areas. I acknowledge that I am personally responsible for learning about the safety of the area, to include visiting the U.S. Department of State's Travel Warning site:
